#### **ORDINANCE NO. 3368**

AN ORDINANCE TO PROVIDE FOR APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF GENEVA, OHIO FROM JANUARY 1, 2025 THROUGH DECEMBER 31, 2025 AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Geneva, County of Ashtabula, and State of Ohio:

SECTION I. To provide for the current expenses and other expenditures required of the City of Geneva, Ohio, from January 1, 2025 through December 31, 2025, the sums set aside and appropriated in "Exhibit A", attached hereto and made part hereof, shall be designated on all appropriate books, vouchers, orders, etc. of the City of Geneva, Ohio;

SECTION II. That there be and is hereby appropriated from the following accounts the sums set forth in said "Exhibit A", for the purposes specified therein;

SECTION III. That the City Director of Finance is hereby authorized to make disbursements from the City Treasury for payments from the foregoing appropriation provided such disbursements are in conformity with the City of Geneva Charter and the general laws of the State of Ohio.

SECTION IV. It is hereby found and determined that all formal actions of this Council concerning and related to the passage of the Ordinance were adopted in an open meeting of the Council, and that all deliberations of the Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with the requirements of the Ohio Revised Code Section 121.22.

SECTION V. This Ordinance is hereby declared to be an emergency measure in the interest of the public peace, health and safety and shall, therefore, go into immediate effect upon its passage and signing by the President of Council.
